# Ensure an effective organisational approach to health and safety



### Overview

This unit is concerned with leading the overall approach to health and safety in your organisation. There are numerous benefits arising from an effective organisational approach to health and safety, including:

1. contributing to the well-being and productivity of all the people who work for the organisation
2. decreasing the risk of injury and ill health to people who work for the organisation and others
3. improving the reputation of the organisation in the eyes of customers, suppliers and other stakeholders
4. ensuring your organisation meets legislative requirements thus minimising the likelihood of prosecution and consequent penalties

For the purposes of this unit, an 'organisation' can mean a self-contained entity such as a private sector company, a charity or a local authority, or a significant operating unit, with a relative degree of autonomy, within a larger organisation.

  - P5 ensure that the health and safety policy is put into practice across the organisation and is subject to review and revision as situations change and at regular intervals
  - P6 ensure ongoing consultation with people who work for the organisation or their representatives on health and safety issues
  - P7 seek and make use of specialist expertise in relation to health and safety issues
  - P8 ensure that systems are in place for effective monitoring, measuring and reporting of your organisation's health and safety performance
  - P9 show continuous improvement of the organisation in relation to health and safety performance
  - P10 develop an organisational culture in which people put 'health and safety' first and make health and safety a priority area in terms of informing the organisation's overall strategy, planning and decision-making
  - P11 demonstrate that your own actions reinforce the messages in the organisation's health and safety policy statement
  - P12 ensure that sufficient resources are allocated across the organisation to deal with health and safety issues

- K22 the organisation's strategy, planning and decision-making processes
- K23 the organisation's culture in relation to health and safety
- K24 allocated responsibilities for health and safety across the organisation

10. You create a sense of common purpose.
11. You use communication styles that are appropriate to different people and situations.
