Promote the Sustainable Utilisation Of Natural Resources in Support of Sustainable Business Practice



Overview

This standard is about working to develop and maintain the sustainable utilisation of natural resources. It describes the skills and knowledge requirements that help to ensure the sustainable utilisation of natural resources. The sustainable use of natural resources is an essential underpinning component for any organisation that relies on the utilisation of natural resources such as minerals, fuels, water aggregates, trees, fisheries, game and wildlife and the countryside itself.

The role described by this standard requires an understanding of the natural resources being utilised by an organisation, including a clear understanding of the economic, social and environmental factors that define sustainable utilisation. It requires the application of this understanding in support of the development of business targets that promote sustainable thinking within organisations. It also requires that organisational activity is reviewed to determine opportunities for improving the sustainability of resource utilisation. The actions taken should address any negative impacts associated with both organisational activities and the economic impact of natural resources. Finally, it requires that ideas for improving the efficient use of natural resources are communicated and shared with others.

Target Group

This standard is for those responsible for supporting the development of sustainable business practice. It is likely to apply to technical staff and managers within organisations, and particularly those with responsibility for implementing environmental policies and programmes..

 - P9 specify procedures for monitoring and evaluating the future utilisation of natural resources by the organisation
 - P10 promote the positive impacts of **sustainable utilisation** to others
 - P11 develop and implement strategies to overcome **barriers** within limits of authority
 - P12 support the implementation of monitoring and control procedures
 - P13 evaluate the impact of measures to improve the sustainable use of natural resources
 - P14 communicate to **stakeholders** the benefits of **sustainable utilisation**
 - P15 encourage **stakeholders'** endorsement of the actions taken to improve the **sustainable utilisation** of natural resources

- K13 how to monitor and evaluate the organisation's utilisation of natural resources
- K14 data collection and analysis
- K15 the interest that stakeholders have in natural resource utilisation
- K16 how to communicate actions and benefits to stakeholders
