Support the safeguarding of potential victims of modern slavery



Overview This standard is for workers who may be in contact with potential victims of modern slavery during the course of their daily duties. These duties may be carried out within an agency that is recognised as a formal referral point for modern slavery victims or it may be within other agencies that have contact with potential victims of modern slavery. It covers what you must do, know and understand to support the safeguarding of potential victims of modern slavery. Potential victims of modern slavery may be adults, children or young people.

This standard is in addition to existing statutory and good practice safeguarding requirements.

Performance criteria

You must be able to:

- 1. communicate at a pace and level suited to potential victims using recommended communication techniques
- 2. keep discussions free from judgement, discrimination and oppression
- 3. work with interpreters when required, in line with organisational procedures and the needs of potential victims
- 4. respond to cultural differences and needs in line with current good practice
- 5. take immediate action where required to safeguard potential victims in line with:
 - 5.1 statutory responsibilities
 - 5.2 your organisation's procedures
 - 5.3 your role and responsibilities
- 6. identify any specific complex needs potential victims may have in line with current safeguarding and modern slavery guidance
- 7. address needs identified in line with your role and responsibilities
- 8. work with potential victims to raise their awareness of personal safety taking into account their specific needs
- 9. mitigate against the risk of re-trafficking or re-exploitation in line with organisational procedures
- 10. promote support services available to potential victims in a format that can be understood
- 11. comply with the rights and requirements of confidentiality when working with potential victims
- 12. share information with other agencies where there is a statutory or other requirement to do so and in line with organisational procedures
- 13. work in partnership with other agencies to safeguard potential victims in line with their needs and your role and responsibilities
- 14. contact policing and law enforcement agencies in line with organisational procedures where you have reason to believe that potential victims:
 - 14.1 are classed as missing persons
 - 14.2 have been abducted
 - 14.3 are at immediate risk of harm
- 15. maintain complete and accurate records of safeguarding actions taken in line with organisational procedures
- use supervision and support to help you manage your reactions to suspected or disclosed harm, abuse or incidents of slavery or trafficking
- 17. maintain your knowledge of current safeguarding requirements

Glossary

Modern slavery

Modern slavery encompasses a range of offences:

- Slavery, servitude and forced or compulsory labour
- Human trafficking
- Exploitation, which includes:
 - Sexual exploitation
 - Removal of organs
 - Securing services by force, threats or deception
 - Securing services from children and vulnerable persons

Safeguarding / protection

Protection is a part of safeguarding and promoting welfare. It refers to the activity that is undertaken to protect specific people who are suffering, or are likely to suffer, significant harm. Safeguarding has a wider remit and includes protection from maltreatment, preventing impairment of health or development, supporting the provision of safe and effective care, and enabling people to have optimum life chances.
